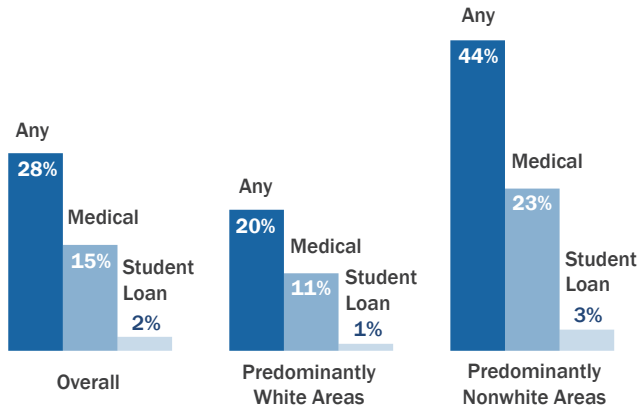

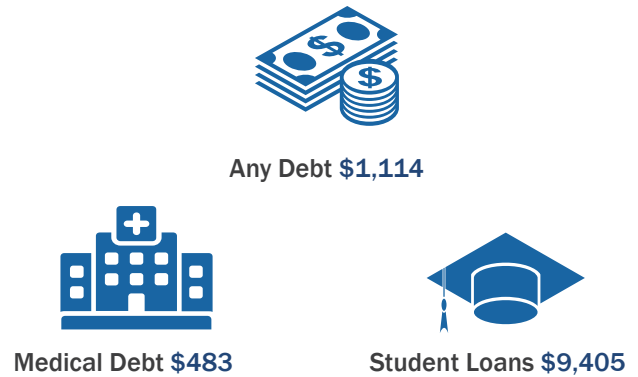

Percentage of New Jerseyans with Debt in Collections



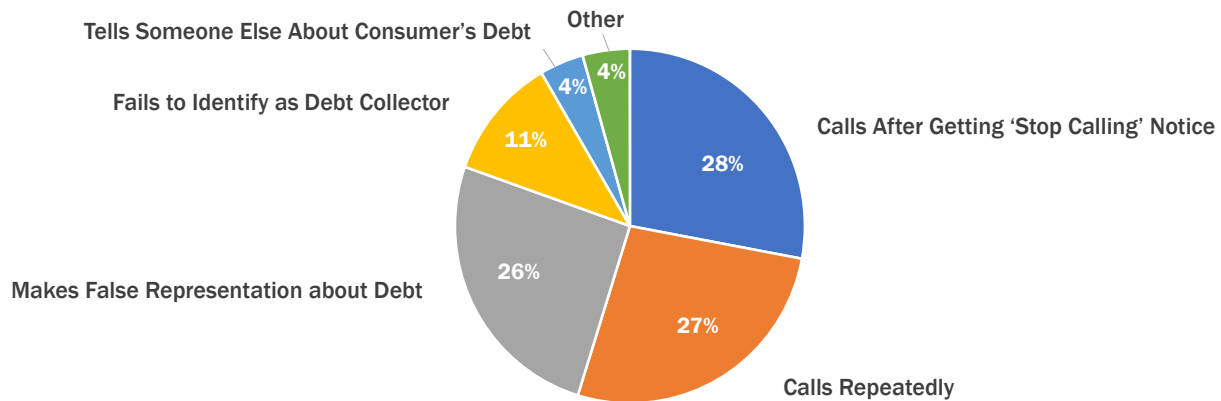
Median Amount of Debt in Collections in New Jersey
