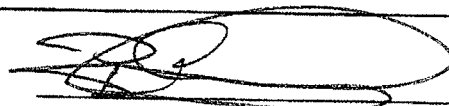

a.m.

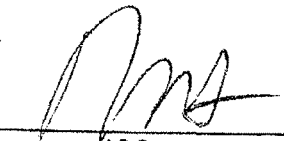
